Messrs. Presidents,

I proudly and humbly presented -with my Andalusian Pride and Turkish Spirit- my Candidacy for the Position of United Nations Secretary-General to the President of the United Nations General Assembly on 2 March 2021.

I courteously sought to be Nominated as a Turkish Candidate while being the only United Nations Staff Member and Female who served for about Twenty Years as the Proud National and Dignified Citizen of the former International Zone and Government of Tangier that was a Member in the League of Nations and the then United Nations until 1956.

My Nomination requests were sent to my Country of Citizenship Turkey that is a Member in Asian Group and Western Europe and Other States Group [WEOG] on 22 February 202I, to my Motherland Spain and my Country of Residency United States of America on 26 February 202I, to Russia, China, United Kingdom and France on 18 March 202I, and to Israel, Australia, New Zealand and Canada on 26 March 202I, while continuing to contact other States.

I have received a letter response from the Chief of the Royal House of Spain, and e-mail responses from the Office of the Prime Minister of New Zealand and the Office of the Governor-General of Canada, all acknowledging receipts of my SG Nomination requests that both Spain and Canada have sent to their Foreign Affairs for consideration.

As I have expressed to Passblue in my First Outdoor Press Briefing that I held on 30 April 2021, I am running in order to fight Corruption and protect the Honor and Dignity of those Minor Boys who have been raped and those Minor Girls who have been both Raped and Impregnated by UN Soldiers in UN Peacekeeping Missions at least for last Decade.

I have not held any political position with any government, but my Two Decades working in UN System -serving in Ten UN Departments both here in New York and Peacekeeping- allow me to run our Organization like nobody else.

The UN Fatal Irregularities are Countless and Contagious. Only when serving in OIOS for about Five Years, the UN Published Reports by Inspection and Evaluation Division confirm that the Majority of UN Departments are run by Wrong Officials. It is like putting a Mechanic in charge of a Department or a Ministry of Health. Yet, this still occurs!

I got the idea of running for UN Secretary-General in 2017 when I served in the Executive Office of the UN Secretary-General, under a Supervision of a Sexual Harasser, known by Two Female Staff in same office, and who is the Director of Political Unit, one of the Failing Team Members that Guterres brought with him from UNHCR in 2017.

During the General Assembly Session of 2017, I was in charge of handling the Readouts of Bilateral Meetings of the Secretary-General with Heads of State and Government. The Readouts are usually prepared ahead of time and are confirmed a day prior to the date of the meeting with a standard language that interprets Nothing but Lies to the World, as what is usually discussed between Guterres and a Head of Country X and/or Y is about His Pocket and Not our Peace.

When Member States complained about the said Poor and Contradicting Readouts, it was stated by the Director of the Political Unit that the Chef de Cabinet who was responsible for confirming them, was Nervous. I was Not nervous!

Messrs. Presidents,

It has been announced by both of Your Offices that a Dialogue would take place with One Only Male Candidate António Guterres on 7 May 2021, Not recognizing the list of about 5 to 7 Female Candidates including myself. I sadly and unfortunately would like to let You -Messrs. Presidents- know that it is Neither right Nor fair to proceed as it is. How will the World trust the UN and Guterres -if reelected- for Women Rights if Women Candidates are Not called for Dialogue?

In 2001, I joined the UN and an e-PAS was invented as a Malicious Tool to either promote or demote a Staff Member no matter how corrupt he/she could be, using it as a Work Performance Evaluation for Job Continuation.

The World knows that António Guterres was born, raised and educated under a Dictatorship System, and served as a Prime Minister during a Socialism Era; then he resigned to prevent Portugal from falling into a Political Swamp. Before becoming UN Secretary-General, he led UNHCR that he left as a Chaos after IO years term. He would do the same now!

Since 2017, he has been leading our Organization laying the Groundwork for Corruption by Firing UN Whistle-blowers of UN Injustice and Silencing UN Journalists who report UN Wrongdoing. Are Member States aware of this?

Guterres ties with China go back to 1999 since the transfer of sovereignty from Portugal to China over Macau. Upon his start in office, he warned Trump Administration that if the U.S. disengages from many issues confronting the international community, it will be replaced. Even though he did not say by which country, we know he intended to replace USA with China. Since then, China has been preparing for this Virus that left us all around the world devastated. Without Guterres being UN Secretary-General, the World would Not have been hit with this Fabricated Pandemic of Covid-19.

Has Guterres as a Candidate furnished all Member States with a Work Completion Report of Five Years Term in Office, highlighting his Achievements and Failures? Which UN Document Number says he can automatically be reelected?

When I was nine living in my hometown and never seen the world nor travelled anywhere, I was told that I was not supposed to continue going to school although I was the first in my class and could speak and write three languages.

Now, I am 49 and I am told that I can't be considered a Candidate for UN Secretary-General position although I spent about 20 years serving the UN, travelled the world living in five continents and can speak and write ten languages.

There is No single man in this globe who would prevents me from saying the truth, doing the right thing, acting for the sake of justice and contributing for peace; let alone a world betrayer Guterres who archives child rape cases in UN.

If I am given the right that I deserve to be treated as a Candidate and should I succeed, I will bring with me to my office every evidence I hold and will issue each guidance I possess in order to clear the Image of the UN from Child Rape.

In case I am discriminated as a Woman Candidate or disregarded as Self-Nominated Candidate, I will display all what I have as evidence about UN Corruption in my Website and Social Media for the world to read, because it is my obligation as a woman with honor and faith to awaken our world population about the Shadow UN run by Guterres.

God brought us to this earth to enjoy it, Not to destroy it! So, let's protect our people and save our planet by electing a UN Leader who values dignity, works for humanity, operates with transparency, and functions with integrity.
