Subject: Complaint about the Secretary-General's Abuse of Incumbency in order to Run for a Second Term

Your Excellencies,

As a Candidate for the Position of United Nations Secretary-General, I am Unique because I have not only worked in the UN for about Two Decades; **I worked as the Assistant to the Director of Investigations** in the Only Independent United Nations Office of Internal Oversight Services {OIOS} where I witnessed UN Cover-Up of Child Rape; **I have also worked as an Assistant in Political Unit** at the Executive Office of the Secretary-General {EOSG}, **on the 38<sup>th</sup> Floor, where I discovered Guterres' Plan to Ruin our Planet.**

My Gain is not only to Win during this Selection Process; it is in fact to **Awaken World Populations to the Harm Hidden Behind the Shadow of the UN** that is the only Worldly System I know how it functions.

The Majority of World Nations have No idea about the United Nations. Moreover, Nobody intends to educate them about the Reality which is that the UN is the only Venue in this Earth where any Malevolent can be employed to Manipulate International Law, Human Rights and UN Charter in order to Commit any Crime against Humanity without being held accountable; and it is the only Workplace that Nobody can sue in any court whether its Officials Lie, rob, harass, bribe, rape, kidnap, kill, instigate terror or declare a war.

The Selection of the United Nations Secretary-General should be the Only Way for us to Reform our only World Body that is drowning in the sea while World Nations are navigating in the sky. Frighteningly, **this Only Hope left for us, to attempt to Rescue our Globe from any further Crisis, has been Openly Stolen by Compromising the said Selection Process** which started with António Guterres Announcing his wish to run for a second term before the Selection Process Began, to his Assignment of the UN Spokesperson as his Campaign Spokesperson, to Traveling to Russia in order to Lobby for his Campaign using UN Budget. Is this Democracy that UN General Assembly and UN Security Council urge Member States to embrace?

***Aide Memoire of António Guterres' Abuse of Incumbency:***

According to the UN PGA Website, there are documents related to events as follows:

- On **11 January 2021**, the GA President sent a Letter to Member States on the Selection and Appointment of the UN Secretary-General, providing them with his **8 January 2021** Letter to António Guterres asking him whether he would seek a second term, and including Guterres' response of **11 January 2021** confirming his availability to Serve a Second Term as Secretary-General of the United Nations.
- On **5 February 2021**, the GA President -together with the SC President- sent a Joint Letter to Member States, serving to set in motion the Process of Selecting and Appointing the UN Secretary-General.
- On **24 February 2021**, the Prime Minister of Portugal sent a Letter to the Presidents of the GA and the SC -through the Permanent Representative of Portugal- presenting António Guterres as a Candidate for the Position of the Secretary-General of the United Nations for the Mandate 2022-2026.
- On same day, **24 February 2021**, the Permanent Representative of Portugal sent the Letter -that he had received from the Prime Minister of Portugal- to the Presidents of the GA and the SC.
- On **26 February 2021**, the President of the GA -together with the President of the SC- sent a Joint Letter to Member States, forwarding the communication received from the Permanent Representative of Portugal presenting Guterres as a Candidate for Re-appointment to the Position of Secretary-General.
- On **23 March 2021**, Guterres sent a Letter and a Vision Statement to the PGA; on same day, same Letter was sent by the Permanent Representative of Portugal to the PGA presenting Guterres as a Candidate.
- On **25 March 2021**, the President of the GA sent a Letter to Member States, circulating António Guterres' Letter and Vision Statement as he was nominated by his Country Portugal.
- **Nothing happened for One Month [25 Mar to 26 Apr] as both the UNGA and the UNSC went Silent!**
- On **26 April 2021**, the President of the GA wrote to Member States regarding the Informal Dialogue Scheduled on **7 May 2021**, with One Only Recognized Candidate, the Incumbent António Guterres.



*Saving Humanity, Seeing the World a Better Place and Serving for Peace and Security*

- On **7 May 2021**, during the Unlawful Solo Informal Dialogue, the One Recognized Candidate António Guterres stated in his speech saying "After considering it carefully, including with my family in **December [2020]**, I indicated to you that I would be available for a second term should this be the wish of Member States".
- Between **12 and 14 May 2021**, Guterres was in Russia Lobbying for his Second Term, Traveling under Member States' Expenses: Your Funds provided for UN Operations and Not his Campaign Donations.
- The UN Spokesperson has been Acting as Guterres' Campaign Spokesman. Why didn't Guterres create a Different Separate Platform to Ethically Run his Campaign under his Own Expenses as a Decent Candidate for UN Secretary-General Position? Is he above UN Rules as he is above U.S. Laws?
- **Since 30 April 2021**, I have been holding Press Conferences as Part of my Face the World Agenda, a Task that the Incompetent Guterres is Unable to carry out because he is Dishonest and a Dictator.
- It came to my attention that UN Reporters -interested in my Campaign, Vision, Workplan and Agenda- were Warned by Guterres and his Team Not to attend my Press Conferences. To this point -Your Excellencies- **Misogyny, Malice and Machination have become Modus-Operandi at the UN?**

As if it was not enough for Guterres to Appeal my case I had won against Ban about OIOS Corruption, to Approve UN Budget to Open a New UN Office in Hungary to hide a Spy UN Staff who received Bribes from a Member State that is known of Bribing António Guterres -in order to carry out Espionage Activity on me being a UN Staff and then to flee Justice in USA, **Guterres and his Team Caution UN Reporters against engaging with me.** If these low-level schemes do not constitute Corruption, what can they depict?

During the **Biased Dialogue set during China's Presidency of SC**, António Guterres appeared Stressed, Panicking and Dropping his papers on the floor. He even Confessed before answering the first round of questions: "There are many questions; so I think to allow for all to participate; I like to be Telegraphiqued in my answers; I apologize because there is not a simple answer to complex questions that is complete, but I believe I need to make an effort to be Telegraphiqued and to simplify the answers even with lost of substance that I apologize for".

Guterres carried out by saying that it is Difficult to Act when there is No Trust among Member States. The worst is that Guterres -at the end of the Illegal Disorganized Dialogue- requested Member States and Civil Society Representatives to Send him the rest of Unasked Questions for him to answer them Remotely and in Writing while performing his Job as a UN Secretary-General, Not as a Candidate. What a Disorder!

Whenever there is a Conflict to resolve or a Fire to cease and which requires Guterres' Action as a UN Secretary-General and a Man, whether it is to save the lives of civilians in war zones or to protect the honor of children raped by pedophiles in UN Peacekeeping Missions, Guterres dissuades you, diverting from topic in question to hide behind his sentences [It is difficult to do so if there is no so; we are doing what we can].


- **Is this a kind of Man Secretary-General whom we would or should entrust with our Peace and Justice?**

The UN PGA Website contains a List of UN Documents that are Reference for the Selection Process of the UN Secretary-General. Neither document indicates a Written Statement that a Candidate should be Endorsed by any Member State, let alone her/his Member State. The World should Witness how Corrupt UN Secretaries-General and UN Officials can Bend UN Charter, Rules and Regulations for their Benefit.

**I call on Member States to address the Illegitimate UNSG Selection Process and I demand a Fair Just Action to Consider the List of Candidates -including Myself- to be called for a Dialogue and Compete with the Incumbent, with NO Discrimination against Us, mainly that most of us are Women and he is a Man.**

Last but not least, I Repeat announcing that **Guterres Represents a Danger to Democracy in our World Body and Poses a Threat to Justice, Peace and Security in our Globe**, Facilitating Bribery and Conspiracy, Covering up Corruption and Fraud, Promoting Sexual Exploitation and Abuse in Peacekeeping, and Firing UN Employees and UN Reporters who Whistle-blow Wrongdoings and Crimes committed within the UN System while Misusing UN Budget: Your Funds; not to mention **how many Wars Erupted and how many Political Unrests Emerged during his tenure as he allows Negotiations about Sales of Arms under UN Flag.**
