Subject: Candidacy of a Turkish Female Citizen for
United Nations Secretary-General Position in 2022

Mr. President,

I am proudly and humbly presenting -with my Andalusian Pride and Turkish Spirit- my Candidacy for the United Nations Secretary-General Position in 2022.

I am courteously seeking to be Nominated as a Turkish Candidate as Turkey is a Member State which participates fully in both Asian Group and Western Europe and Other States group {WEOG}. My aim is to show to the World that Tangier and Turkey are for World Salvation.

For election purposes, Turkey is considered a Member of WEOG only. This surely makes me a Perfect Candidate since the current Secretary-General Mr. António Guterres is from Europe while he succeeded a Secretary-General Mr. Ban Ki-moon from Asia after the prior Secretary-General Mr. Kofi Annan who was from Africa.

Considering my Origin, I am a Citizen of the former Spanish, Portuguese and British City, International Zone and Government of Tangier that was a Member in the League of Nations and the then United Nations until 1956, and was administered by Spain, Portugal, The Netherlands, Sweden, Italy, Belgium, France, United Kingdom and United States of America.

Since I served the UN for about twenty years as the only Tangier National, I am considered from a Minority Group; this also allows me an opportunity to prosper in my Candidacy as a Female Candidate with a Diverse Culture and an International Background.

In addition, I am a U.S. Permanent Resident and a New York Citizen by American Law.

I have not held any political position with any government, but I have accumulated an expansive up to two decades UN experience especially that I served in both UN Headquarters here in New York and in UN Peacekeeping Missions.

Moreover, the majority of Member States have been emphasizing for several years that any future potential Secretary-General should be a female and should demonstrate proven leadership, managerial abilities, extensive international relations, and strong diplomatic, communication and multilingual skills.

Managerial abilities, communication and multilingual skills are my expertise, and I am willing to work hard to prove my efficiency in leadership and my effectiveness in diplomatic and international relations, notably that I already traveled the world and lived in five continents.

I have a vital reason for Running for the UN Secretary-General Position because I will eliminate fraud, fight corruption, wipe out discrimination, abolish gender inequality, exterminate violence against women, banish colonization, eradicate illiteracy, prohibit ethnic cleansing, ban terrorism, stop wars, combat human, sex and drug trafficking, and put an end to paedophilia. I am enclosing together with this letter both my vision statement and my resume for Your perusal.

Saving Humanity, Seeing the World a Better Place and Serving for Peace and Security

Mr. President,

I know I am facing a World-Shaking UN System under the leadership of Mr. Guterres who transformed the UN to a platform for corruption laying the groundwork for retaliation against UN loyal employees who whistle-blow any sign of wrongdoing. However, I am fearlessly running because I believe that I was born to do the right thing at the right time.

I am confiding in Your Excellency as a Tangier Born Woman who want to take my Country Turkey to the Highest Level of World Diplomacy. My ancestors in Andalusia made history; so do I. And people from Turkey, that I am willing to represent as a UNSG, also made history; so do I. I came too far with my achievements in my life and career; and all I gained as success is thanks to my Herculean Strength and Turkey's Wealth offered to me by adopting me as a Citizen since my Homeland the former Free and International Tangier had and has no more government or flag to pledge allegiance to. My blood is Spaniard, but my Boldness is Turkish.

Becoming the First United Nations Female Secretary-General who hold about two decades of UN experience, has traveled around the world living in five continents, have a background in aviation and investigation, and communicate bravely in at least seven languages including UN official languages, is an Honor for me, a Pride for my precious Homeland Tangier and a Prestige for my beloved Country Turkey.

Therefore, I count on Your Excellency to consider my Candidacy from Turkey.

I have presented my request for Nomination to our Leader the President of Turkey, the King of Spain my Motherland, and the Permanent Representative of USA my Residence Country.

I am also in the process of presenting my request for Nomination to Countries that I am linked to either through the History of my Land Tangier, or via my Life Journey studying and working: Portugal, Greece, Romania, Sweden, Italy, The Netherlands, Belgium, France, Israel, United Kingdom, Argentina, Australia and Brunei Darussalam, as well as other Member States.

In the meantime, I will be presenting my Candidacy to the Security Council Members.

During the last decade, I have been considered Stateless although the UN refused to enlist me in the Stateless Quota. Regardless, I held No passport and did Not travel overseas since 2011.

Having served the UN with a Previous Citizenship and having separated from the Organization, I am a Candidate to UN Secretary-General Position with a Turkish Citizenship.

I already Renounced from my Prior Citizenship before I Obtained my U.S. Residency.

Presenting my Candidacy for UNSG Position as a U.S. Permanent Resident, I would like to inform you that I have contacted the U.S. Congress seeking relevant Taxation Requirement.

In the meantime, I have communicated the same to the U.S. Ambassador to the UN.
