Motives: No to Child Abuse!
No to Violence against Girls and Women!
No to Sexual Harassment by Moroccan Government Officials!
No to Abuse of Authority by Moroccan Aristocrats!
No to Moroccan Government's Threat to Moroccans who serve in International Organizations!
No to Rape of Children and Girls!!!
Enough is enough!!!!!!

Mr. Consul General and Mr. Ambassador,
As a completion of my Renunciation from the Moroccan Citizenship, I am returning my Moroccan ID Card and Passport that were both issued in December 2012 and which I never used.

As you can see, the ID Card is cut pieces as there are no restrictions written on it specifying how to void it or avoid destroying it; while the passport is fully wet and partially burnt in order to protect my identity from any fraud that your Government may intend to commit imputing me.

I have no trust in your Authorities. Therefore, I must be obliged to be cautious and do what I can to prevent any wrongdoing, misconduct or corruption by your Malicious Government Officials.

Since the Key Recommendations at the back cover of the passport indicate that its pages should not be cut-off, nothing should be written-off on its pages and no information should be changed on its pages, I have proudly and confidently followed the instructions and have decided to soak the passport in water and burn part of its front cover and some of its pages to make it invalid for any fraudulent use. This way I am protecting my name from any potential risk or harm.

I hope my bold fearless action justifies to you and to your Government how much I suffered and shows you the degree of pain your Nationality caused me. This is the least I can do in order to:


- 1- defend my honour and dignity against the sexual harassment I received from your Ruthless Chef de Cabinet Rochdi Chraïbi -Your King's Close Friend and Classmate- who disdainfully requested to have sex with me to provide me with protection as a Moroccan Citizen;
- 2- defend my honour and dignity against the humiliation and discrimination I received from your previous Racist Permanent Representative Mohammed Bennouna who kicked me out of his Office when I visited him in order to complain about his Friend Rochdi Chraïbi;
- 3- defend my honour and dignity against the sexual harassment I received from your Psycho Diplomat in Argentina Hassan Rakkas who disrespectfully phoned me at midnight to engage me in a shameful conversation about sex and asked me about the size of my breast;
- 4- defend my honour and dignity against the sexual harassment I received from your Vulgar Diplomat in Australia Brahim Boudani who requested to visit me and have sex with me;
- 5- defend my honour and dignity against the abuse of power and authority by your Rude Ambassador in Argentina and the then Ambassador in Australia Mohammed Mael Ainain who viciously covered up the misconduct of his Employees Hassan Rakkas and Brahim Boudani and mercilessly threatened me for having served in and helped Timor-Leste which he confessed is considered the Enemy of Morocco because it supports the Western Sahara.
- 6- defend my honour and dignity against the sexual harassment I received from your Delinquent Human Rights' Specialist Mohamed Achgalou who approached me drunk to openly tell me that Moroccan Women are strong because they decide sex position in bed;
- 7- defend the honour and dignity of the Illegal Immigrant African Girl who insanely was raped by the Moroccan Royal Guards in my Hometown Tangier and the case was covered up.
- 8- defend the honour and dignity of every Underage Girl who has been raped and left either pregnant, injured, handicapped or slaughtered by the Moroccan Peacekeepers in Africa;
- 9- defend the honour and dignity of every Child raped by the French Peacekeepers in Africa since Morocco disreputably keeps paying Bribes to France so that France -as the Permanent Member of the Security Council- defends Morocco to claim the Fake Moroccan Sahara.
- 10- defend the honour and dignity of those Kids raped by the Iraqi Paedophile who received Royal Pardon from your King and escaped Justice by paying Bribes to your Government.

Freeing my Person from your Nationality is indeed cleaning my blood, brain and body from a Deadly Disease that is worse than Cancer and Ebola; it is the First Step towards the Liberation of my Hometown Tangier from your Colonialism, Corruption, Dictatorship and Deceit - inshallah!
